Cancellation & Refund Policy: Students will be entitled to tuition refunds or cancellation of charges for tuition, other than the \$40.00 application fee in accordance with the following schedule below. The Tuition Deposit is non-refundable, unless a student is denied a study permit by immigration authorities. The New Student Fee, The Technology fee and Orientation Fees are not refundable after the first day of Orientation.

- Prior to the first day of the Program: 100% refund of tuition (less Tuition Deposit)
- During the first week of the Program: 90% refund for tuition charges only
- During the second week of the Program: 80% refund for tuition charges only
- During the third week of the Program: 60% credit for tuition charges only
- During the fourth week of the Program: 40% credit for tuition charges only
- During the fifth week of the Program: 20% credit for tuition charges only
